Summary of 2023 (Stephanie)

- Plant Sale May 2023
 - O First time having additional vendors
 - O Thank you to Try Recycling for the mulch and compost and Springtime Garden Centre for the annuals
- Harvest Fest November 2023
 - O Thank you to Justin from BVR for mc-ing and all the volunteers who helped
 - O Over 100 neighbours in attendance
- Tree Sale
 - O Thanks to Variety Cafe and the vendors
 - O Struggled to raise enough money to make this a sustainable event
 - O Hoping to replace with another holiday event
- Heather McKay
 - O We unfortunately lost one of our board members, vice-president Heather McKay passed away unexpectedly in the Fall
 - O Heather was a board member for 4 years and put many hours into the WCA and events

Presentation from Indwell Housing (Julie Ryan)

- Indwell operates properties across Ontario
- Charity organization
- Creates affordable housing communities
- Located in cities across Ontario
 - o 1200 plus tenants across province
 - o 92% housing stability rates
- Provide on-site supports for healthcare, housing, food security, life skills training, recreation, addiction support, etc.
- 600 people are living unsheltered (tents, doorways)
- 2000 people homeless (living in shelters, hotels, couch surfing, etc)
- 200 people died last year because of homelessness
- Woodfield Gate 356 Dundas Street
 - o Opened 2019
 - o 66 apartments
 - o 35 people were cycling through the hospital and healthcare system before attaining housing at this building
- Embassy Commons 740 Dundas Street
 - O Opened November 2022
 - o 72 units
 - Commercial spaces on ground level including Edgar and Joes café, Squeaky Wheel Bike Coop
- Thompson Road Apartments 403 Thompson Road
 - O Opened October 2023
 - O 44 studio apartments
 - O Operates in partnership with the City of London
- Vision Soho Alliance in progress
 - o Former grounds of the former Victoria Hospital
 - o 6 non-profit developers
 - o 680 plus units for half market rent and half affordable rent
- New building also coming in Manor Park/The Coves area
- How can we help?
 - Always looking for volunteers for programs, facilities, maintenance, and fund raising
 - Can also give monetary donations directly

- Questions from the audience:
 - O How is rent determined?
 - A proportion of their Ontario Works or Ontario Disability Support Program put towards rent (approximately 50%)
 - O Is there food available to those who cannot cook for themselves?
 - Common meal is served at some facilities daily

- Also help with grocery shopping, food bank, cooking classes
- O Have there been any concerns with trespassers, loitering?
 - Policies and practices are in place to deter unwanted activity and crime and at times police are involved

Presentation form Councillor for Ward 13 (David Ferreira)

- Neighbouring communities have lost their own community associations
 - O David is working hard to help communities like SOHO redevelop their own community associations
 - O Important to keep associations like the WCA going
- New multi-year budget in progress
 - O Looking for engaged feedback from citizens
 - O In the past not many have stepped forward to provide feedback, questions, and express concerns
 - O David is hoping that the mayor's office will provide a document to outline the major parts of the upcoming budget so that people can become engaged ahead of time
 - O New legislation and process means that the budget comes directly from the mayor's office (based on new Provincial "Strong Mayor" powers)
- Voter turnout on last election was approximately 25%
- Questions and comments from the audience:
 - O How does the "Strong Mayor" legislation change how we should be voting?
 - Counsellors have lost the ability to advocate and change things the way they used to
 - Community members worry that "Strong Mayor" powers further discourage people from voting
 - Requires change on local and provincial levels
 - Counsellors still act as advocates
 - Mayors still have some choice in acting on "Strong Mayor" legislation
 - May impact some level of funding
 - O Loss of business and stores, etc. on Richmond Row, Dundas Place, etc. not directly in Woodfield but impacts our community
 - Loss of businesses but also lots of new businesses opening
 - Downtown Master Plan brought forward by David to revitalize the area, create boundaries, encourage amenities and services
 - O Are their rules/restrictions to buildings in the downtown area that require residential buildings to have groceries stores, etc. (like cities such as Toronto)
 - Not currently
 - O Status of vacant property tax
 - A motion has been put together by David and another counsellor to propose
 - Not sure yet if it will combine both commercial and residential properties
 - O Concerns from developers that new projects get held up in the application process
 - Some applications are processed but never go through, can hold up the process for everyone

- Working on a potential clause that will force development that puts a timeline on when development must happen after planning application
- O With pressures to create more housing, will there be an impact on things like heritage bylaws
 - Not currently
 - Other community associations are also very passionate about this topic
 - Depends on votes from all counsellors, not just those representing heritage neighbourhoods
 - Need to encourage appreciation of heritage buildings and history amongst all of London

Planning report (Stephanie)

- 300 and 306 Princess Ave official plan and zoning bylaw amendments
 - O Currently these buildings are boarded up
 - O Designated heritage properties
 - o WCA reached out to developers to have a conversation about proposals
 - o 3 story addition to back of properties (current height)
 - O Increasing number of units on property
 - O No plans to impact heritage aesthetic
 - o WCA is supporting this kind of development and density to encourage growth
- ReThink Zoning comprehensive zoning bylaw review
 - o Still underway
 - O Impacts every property in the city
 - O Complete overhaul of the zoning bylaws
 - o WCA plans to review and provide input on behalf of community
 - O City has a website dedicated to this with a way to provide input

- Concerns brought forward from community regarding Woodfield motto "residential to the core" and the connotation of "residential"
 - O Changing motto to "community to the core"
